WHAT INFORMATION DO WE COLLECT ABOUT YOU?

HOW WILL WE USE THE INFORMATION ABOUT YOU?

We also store information regarding qualifications and certificates that you have obtained through us and to enable the administration of replacements.

We use your information collected from the website to personalise your repeat visits to our website. We also use it in our analysis of general visitor behaviour in order to improve the user experience and to better direct our sales. We do not pass on your personal information to other companies (other than the RYA in connection with registering certificates).

On successful completion of an RYA SRC course, your name, contact details, date of birth, certificate number and date of issue will be shared with the RYA through a secure web portal. The data will be stored on the RYA's central database. This information allows the RYA to record you qualification, to update any records they may hold for you, and to verify or replace your certificate if required.
